How Much Will My Chapter 13 Plan Payment Be?

If you start saving from a younger age, you'll be required to save much less each month. Couples who start saving at the age of 20 with no pension savings would need to contribute £213 per month collectively for a comfortable retirement, whereas if both parties started saving at age 40 they'd need to save £384 per month.
